## **Registry Guidelines**

*Approved February 7, 2006*

**A registry is the heart and core of breeding as it helps to preserve the history of a breed. Only by accurate documentation can a breeder follow generations of dogs, establish healthy bloodlines, and preserve the purebred Xoloitzcuintle.**

**Xoloitzcuintle from XCUSA registered parents are eligible for XCUSA registration. Xolos with registration from an XCUSA acceptable registry are eligible to apply for XCUSA registration.**

**Dogs without XCUSA registered parents do not meet XCUSA's registration requirements but may apply for registration through visual inspection. These dogs may submit proof and acceptance from inspection in Mexico or may be inspected by an XCUSA certified inspector. Applicants must fill out an application form and include two pictures: a side view, standing, and a front view, standing, in addition to documentation from their primary registry.**

## **Registration Divisions**

- **Full registration:** Full registration may be requested for dogs with parents registered with XCUSA or another XCUSA *accepted registry*. Full registration is for breeding and show quality animals.
- **Limited Registration:** Limited Registration may be requested for a dog when application for individual registration of the dog is submitted, provided the application, together with a request for such limitation, is filed by the owner(s) of the litter at birth.

No offspring of a dog for which Limited Registration has been granted is eligible for registration. Each registration certificate for such dog shall carry notice of the limitation, and the limitation shall continue, regardless of any change of ownership, unless and until the owner(s) of the litter at birth shall apply to XCUSA for removal of the limitation. These dogs must be spayed or neutered.

Dogs with Limited Registration may compete in Companion events, i.e., obedience and agility.

- **Indefinite Listing Privilege (ILP):** For dogs determined to be purebred, but of unknown parentage. These dogs must be spayed or neutered. An ILP number allows the dog to compete in Companion events (obedience & agility).

## **XCUSA Acceptable Registries:**

- **Federacion Canolfila Mexicana, A.C. (FCM/FCI)**
- **United Kennel Club**
- **Xoloitzcuintli Club of America**
- **Foreign Registries, other than FCM/FCI will be on a case-by-case basis. XCUSA will consider Xoloitzcuintle from any of the 80 FCI affiliated registries.**

**Single Registration Application - Usually for dogs whose parents are not XCUSA registered. Dogs must be registered with a registry acknowledged by XCUSA and show proof of such by submitting a copy of the Registration Certificate and pedigree from that registry. When requesting application, be sure to indicate age and current registry.**

Litter Registration Applications - Both Sire and Dam must be XCUSA registered. Temporary puppy Registration Certificates are issued for each puppy in the litter and applied for by the breeder. Litters must be registered before pups are a year old. Litters over one year old will need to apply for a waiver and will be considered case-by-case. Breeders may apply for permanent registration papers on any pup they plan to keep.

No dog or litter out of a dam under eight (8) months or over ten (10) years of age at time of mating, or by a sire under seven (7) months or over twelve (12) years of age at time of mating, will be registered unless the application for registration shall be accompanied by an affidavit or evidence which shall prove the fact to the satisfaction of XCUSA.

No individual dog from a litter whelped in the United States of America of which both parents are registered with the Xoloitzcuintle Club USA shall be eligible for registration unless the litter has first been registered by the person who owned the dam at the time of whelping, or by the lessee if the dam was leased at the time of whelping, and, further, that an application to register such litter is filed with the XCUSA
